HTC REPORTS THIRD QUARTER 2022 RESULTS

Taipei, Taiwan – November 1, 2022 – HTC Corporation (TWSE: 2498), a global leader in innovation and design, today announced consolidated results for fiscal 2022 third quarter ended September 30, 2022.

3Q22 Financial Highlights :

- Quarterly revenue of NT\$1.08 billion with a gross margin of 39.4%, up from 39.2% last quarter.
- Quarterly operating loss of NT\$1.14 billion with an operating margin of -105.3%.
- Quarterly net loss attributable to owners of the parent was NT\$0.98 billion, or an EPS of -NT\$1.19.

3Q22 Business Update :

- HTC announced the launch of the brand new VIVE Focus 3 Facial Tracker and Eye Tracker, as well as Location Based Software Suite (LBSS), promising a more realistic interaction experience in the all-in-one VR headset.
- HTC officially brought VIVE Mars CamTrack to market at the SIGGRAPH 2022 conference with a media tour, and followed with a partnership announcement with Aximmetry at the IBC 2022 conference to create an outstanding package for virtual production.
- HTC partnered with MyndVR on the launch of their DigitalTherapyNOW website in support of the Access to Prescription Digital Therapeutics Act of 2022. The Act would designate VR devices as prescriptive therapeutic treatment, opening the door for millions of patients to benefit from the tech.
- HTC partnered with MyndVR and Virti to demo devices to policy makers at the ARVR Policy Conference in Washington, DC.
- HTC showcased VIVERSE at the World 5G Convention 2022 in Harbin. Over ten thousand visitors came to HTC's booth during the four-day conference, trying products and filling out survey, providing valuable insights for market research and analysis.
- In collaboration with Supermicro at MWC Las Vegas, HTC demonstrated Private 5G Reign Core, 5G 3D Visualization, and 5G Cloud VR at the Supermicro booth.
- VIVE Arts partnered with the Triennale di Milano to present its first VR exploration titled *1923: Past Futures* at the 23rd International Exhibition.
