



HTC REPORTS FIRST QUARTER 2023 RESULTS

Taipei, Taiwan – May 3, 2023 – HTC Corporation (TWSE: 2498), a global leader in immersive and connected technologies, today announced consolidated results for fiscal 2023 first quarter ended March 31, 2023.

1Q23 Financial Highlights :

- Quarterly revenue of NT\$0.98 billion with a gross margin of 40.8%, up from 40.5% last quarter.
- Quarterly operating loss of NT\$0.97 billion with an operating margin of -99.0%.
- Quarterly net loss attributable to owners of the parent was NT\$0.68 billion, or an EPS of -NT\$0.82.

1Q23 Business Update :

- HTC launched its new cutting-edge headset VIVE XR Elite at CES 2023. The device received “Best of CES 2023” awards from CNET, CNN, Wired and more, attracting extensive attention worldwide.
- At MWC 2023, HTC demoed VIVE XR Elite and its MR Gasket, Mars CamTrack, and the latest immersive drama *Light the Night: Redhat Killer* by BEATDAY. We also announced “VIVERSE for Business” and our new private 5G solution REIGN CORE S2. We received “Best of MWC 2023” from media, and held top-tier media interviews including with *The Wall Street Journal* and Bloomberg TV.
- HTC VIVE attended the “XRA Demo on the Hill” event in Washington, DC and showcased technology for Members of Congress and staff. The event had more than 100 attendees from over 55 Congressional offices. HTC VIVE demoed VIVE Focus 3 running our partner Virti’s healthcare training content, and VIVE XR Elite running Open Brush as a passthrough tech demo. Staffers and representatives were impressed with the demo and the implications for healthcare training.
- At SXSW 2023, HTC VIVE participated in activations and/or speaking spots with several partners including the XR Association, Wide Awake, Yuki, and Ristband, allowing guests to try out VIVE XR Elite and experience its feature set. We moderated a panel with partner Wide Awake VR on the topic of VR distraction therapy, and also participated in a panel with the XRA on accessibility in XR.
- At Game Developers Conference (GDC) 2023, HTC held a preview of our upcoming self-tracking tracker with media, influencers, and developers. There were over one hundred developers joining the event, and has received a lot of publicity.
